

## Owner Agreement

I, \_\_\_\_\_, hereby certify that my dog(s):  
\_\_\_\_\_ is/are in good health, have not been ill with any communicable diseases or parasites in the last 30 days, and have not harmed or shown aggressive or threatening behavior towards any person or any other dog. I also have read and understand and agree to the following:

1. I understand that Bed & Bark is an open-play environment and because of this there are inherent risks, which even when closely monitored, may result in the following:
  - a. Transfer of a communicable illness such as, but not limited to, "kennel cough," also known as the Bordetella virus, "puppy warts" also known as the canine papilloma virus, or parasites.
  - b. Injuries, usually benign, such as broken nails, sore pads, puncture wounds, abrasions and cuts, particularly in shorter coated breeds, etc.
  - c. Behavioral problems.
2. Bed & Bark and their staff will not be liable for any health or behavioral problems that develop in my dog(s), and I hereby release them of any liability of any kind whatsoever arising from my dog(s)' attendance and participation at Bed & Bark. If health or behavioral problems develop with my dog(s), these will be treated as deemed best by the staff of Bed & Bark within their sole discretion, and that I assume full financial responsibility for any and all expenses involved.
3. If my pet appears to be ill, Bed & Bark will first contact me to discuss concerns. If I am unavailable and the concerns are determined to be serious or life-threatening, I authorize Bed & Bark to engage in the services of the veterinarian-on-call at the Veterinary Center of Hudson at my expense, and all decisions will be made in the best interest of my pet's health. I agree to pay all veterinary charges incurred by my pet while in the care of Bed & Bark and I will not hold Bed & Bark liable for failure to seek veterinary attention or for decisions made under the contract. All reasonable attempts will be made to contact you immediately in the event of an emergency.
4. I am solely and financially responsible for any harm to any other dog(s), to the employees or invitees of Bed & Bark, or to the equipment, physical plant, or other property of Bed & Bark, caused by my dog(s) while my dog(s) is/are attending the facility.
5. Photographs or other graphic, sound, or other image, likeness, recording, etc., may be made of my dog(s) by Bed & Bark and that such may be used for any purpose without compensation, and I release to Bed & Bark all rights that I may possess or claim to such image, likeness, recording, etc.
6. I agree to pay the rates that are in effect at the time my pet is at Bed & Bark. I am aware that extra charges may be incurred and I agree to pay them at the time of pick-up. Examples include but are not limited to: daycare, grooming, activities, boarding, medical care, exam fees, vaccination fees, feeding charges, and late fees.
7. I have received, read, understood and agreed to the terms outlined in the Bed & Bark document, "Our Policies," which are made part of this agreement, and I have read and understood all terms of this agreement.
